



Social Media Contest Rules (V2.0)

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: Contests are open only to those who “LIKE” the Community Spirit Gaming Facebook Page, OR “FOLLOW” the Community Spirit Gaming Twitter account, OR “FOLLOW” the Community Spirit Gaming Instagram account, and who are 18 as of the date of entry. Contests are only open to legal residents of Ontario, and is void where prohibited by law. Employees of Community Spirit Gaming and Treasure Chest Bingo, its affiliates, subsidiaries, advertising and promotion agencies, (collectively the “Employees”), are not eligible to participate in contests. The contests are subject to all applicable federal, provincial, and local laws and regulations. Void where prohibited.

Content provided through Community Spirit Gaming Centres' social media channels is intended for an adult audience. Individuals must be 18 years of age or older in order to physically enter the Charitable Gaming Centre. Government Issued Photo Identification may be required to prove an individual's age. Individuals must be 18 yrs + in order to participate in any lottery and gaming activity or any promotions or contests associated with Community Spirit Gaming Centre. Government Issued Photo Identification may be required to prove an individual's age.

Potential Winners of any social media contest will have to come to the Charitable Gaming Centre in Kingston, Ontario, to complete and sign a release form prior to their potential win being official. At this time potential winners will have to provide government issued photo identification suitable to management in order to ensure compliance with the age restrictions. Failure to follow all Social Media Participation Guidelines and/or Social Media Contest Rules including but not limited to the age requirements may result in the disqualification of potential winners. In this case another potential winner will be chosen to be awarded the prize in keeping with all rules and regulations.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Community Spirit Gaming as final and binding as it relates to the content of this contest.

3. Contest Period: All entries must be received by date specified on the Facebook post, Twitter tweet, or Instagram Post.

4. How to Enter: The contest must be entered by “LIKING” Community Spirit Gaming Facebook Page, or “FOLLOWING” the Community Spirit Gaming Twitter account, or “FOLLOWING” the Community spirit Gaming Instagram account, and participating by “liking” and “commenting” on specified posts. The entry must fulfill all contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Community Spirit Gaming. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Community Spirit Gaming.

5. Prizes: The Winner(s) of the contests (the “Winner”) will receive the prize as specified. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by Community Spirit Gaming. No cash or other prize substitution shall be permitted. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, provincial, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for Community Spirit Gaming to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner will be selected by a random draw under the supervision of Community Spirit Gaming. Winner will be notified by either Facebook, Twitter, or Instagram messaging within two (2) days following selection of Winner. Community Spirit Gaming shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 7 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this contest is conditioned upon compliance with any and all federal, provincial, and local laws and regulations. Rights Granted by You: By entering this content (e.g., photo, video, text, etc.), You understand and agree that Community Spirit Gaming, anyone acting on behalf of Community Spirit Gaming, and Community Spirit Gaming's licensees, successors, and assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity and throughout the World, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the contest, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes without any further compensation, notice, review, or consent.

9. Terms & Conditions: Community Spirit Gaming reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the contest should virus, bug, non-authorized human intervention, fraud, or other cause beyond Community Spirit Gaming's control corrupt or affect the administration, security, fairness, or proper conduct of the contest. In such case, Community Spirit Gaming may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Community Spirit Gaming. Community Spirit Gaming reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the

contest or website or violates these Terms & Conditions. Community Spirit Gaming has the right, in its sole discretion, to maintain the integrity of the contest, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by contest rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the contest may be a violation of criminal and civil laws. Should such attempt be made, Community Spirit Gaming reserves the right to seek damages to the fullest extent permitted by law.
